PURPOSE OF FILING:

This filing complies with Wyoming HB 37 to eliminate the \$3.50 State Telephone Assistance Plan (TAP) credit for residential customers.

The filing also increases the rate applicable to the Late Payment Charge and the Convenience Fee for residential and business customers effective July 1, 2015. The late payment charge applies to all billed balances which are not paid by the billing date shown on the next bill. The Convenience Fee is an optional charge assessed when customers request a one-time payment, either by electronic funds transfer or by credit card.
